You may wish to have a presence on the Park merely to publicise your business, and let Festival-goers know more about what you do – or you may have products to sell, or a service to take orders for.

Festival is all about providing entertainment on the day, covering the costs (hiring Westbridge Park from the Borough Council, hiring the toilets, paying the professional entertainers ...) and making a surplus to be disbursed to local good causes after the event. One of Festival’s sources of income is the charges made to commercial stallholders. These are negotiated on an individual basis – either a fixed sum, or a percentage of sales on the day.

Once you have submitted a form, we will contact you to negotiate the fee.

If you are interested in being on the Park – then let us know a bit about yourselves, and what you would like to do – and we can start talking about a mutually acceptable price.

Please note that you will need to set up your “stall” and remove any vehicles before the event starts – and will not be able to bring vehicles back to your stall until the official end of activities (5pm). Also please note that only the Festival Beer Tent will be licensed for alcohol sales, and consumption of alcohol will only be allowed in a designated area around the tent. This means it will not be permissible to (i) consume alcohol elsewhere in the park, or (ii) offer alcoholic drinks for sale or as prizes on other stalls.

As noted on the form, the organisers merely provide an area of grass – stallholders must bring with them everything that they need – getting everything set up before 12 noon and taking it all away with them afterwards. For safety reasons, we enforce a vehicle standstill period from 12 noon until 5pm.

All stallholders MUST ensure that ALL helpers are aware of and comply with the alcohol and movement restrictions described above.

Where helpers will be entering the park during the afternoon, a limited number of “Free” pass-ins can be supplied (but the fee charged for the pitch may reflect the number of pass-ins issued). There will be NO free admission for helpers after the gates are manned unless they have a pass-in.

We will require you to provide evidence of appropriate Public Liability insurance before you may take part.

We confirm that any goods offered for sale have been legally obtained, fully satisfy the requirements of relevant Consumer Protection/Health/Safety/Environmental Protection legislation, and do not infringe the copyright or other Intellectual Property Rights of any third party. Furthermore, we indemnify Stone Festival Committee and its helpers from the consequences of any breach of the above requirements.

We will provide evidence that we have suitable Public Liability insurance before arriving at the Park.

We agree that, in the interests of Health and Safety and co-operation between stallholders, all our helpers on the day will abide by the vehicle standstill period and follow any instructions given by a member of the SFC.
